A regular meeting of the Planning Board was held on Wednesday, May 21st, 2014. The meeting convened at 7:00 p.m. in the North Street Fire Station.

Approval of Minutes: Mr. Reid made a motion to approve the minutes from the May 7th, 2014 Planning Board meeting. Mr. Famolare seconded the motion and the vote was unanimous.

Items:

- 1) 140401 Gerald Dworkin—Site Plan Review—Public Hearing—for approval to re-surface the parking lot at his business, Lifesaving Resources. [3 Mills Road, identified as Assessor's Tax Map 22, Block 007, Lot 31 in the Cape Porpoise Square Zone.] Moved to June 4th agenda at the request of the Applicant.
- 2) 140402 Deidre, Scott & Kailey Lewis Site Plan Review Public Hearing for approval to turn a retail use space into a take-out food space. [4 Spring Street, identified as Assessor's Tax Map 11, Block 002, Lot 25 in the Dock Square Zone.]
- Mr. Kling introduced the Agenda item. Mr. Scott Lewis addressed the Board stating the retail space was most recently used as the CatWear clothing store and prior to that occupant it was a take-out pizza place.
