6. ENVIRONMENTAL ISSUES

All dredge material is currently stored/contained at the Town of Kennebunkport Public Works facility on Beachwood Ave., Kennebunkport. T. Buck is planning to dispose of the material at Waste Management, Turnkey Landfill, 90 Rochester Neck Rd., Rochester, NH 3839

7. TRAFFIC ISSUES

- ⇒ The Phase 2 Kennebunk approach is being maintained daily to assure the gravel roadway is in good condition.
- ⇒ Installed 2 "DO NOT BLOCK DRIVEWAY ENTRANCE" signs will be installed at the Kennebunk approach, right side; 1 will be located before the Shipyard entrance and 1 before the Pilot House entrance.
- ⇒ 6 "ALL LOCAL BUSINESSES OPEN" signs will be installed at various project approaches.
- ⇒ 2 "NO MOTORIZED VEHICLES" AND 2 "PEDESTRIAN ONLY" signs will be installed at the pedestrian bridge approaches.

- 9. FIELD OBSERVATIONS (problems, conflicts, changes and problem resolutions)
 - ⇒ Bill Hodgkins and Harold Pottle verified removal limit elevations as detailed and required for A1 and A2; this requirement is noted on plan sheet 19 of 51. Abutment 1 granite is 6" below the required precast grade; Abutment 2 granite is 4" below the required precast grade. Tim Merritt, Stantec, will look into the submitted and approved non-shrink grout mix design and determine if the mix meets the design requirements for the abutment grout bed in the 4" 6" thickness range.
 - ⇒ Stresscon is providing camber growth management information for the box beams during the detensioning and beam curing phase.
 - ⇒ The Bridge Advisory Committee and the Town of Kennebunk approved T. Buck's request for night work during bridge removal operations. The Town of Kennebunkport Board of Selectmen are meeting on Thursday, 2/23/17, and will vote on the night work request at that time.
 - ⇒ Variable message boards will be positioned at 4 project approach locations to notify the travelling public of the upcoming 3/6/17 4/20/17 (45 Day) bridge closure of the Mathew J. Lanigan Bridge.
 - ⇒ T. Buck will make all required notifications of the bridge closure by Wednesday, 2/22/17.
